## RECOMMENDATION

#### FROM WHO? AND HOW MANY?

Your goal is to find the people who can address the important aspects of you in the best and most comprehensive light possible. Usually the people you choose are either a supervisor or professor, former or current. The letter writer should know you well in one or more of the following areas:

- Academic ability
- Interpersonal skills
- Work ethic
- Leadership qualities
- Ability to function on a team

## RECOMMENDATION

#### FROM WHO? AND HOW MANY?

- Always give adequate lead time: 4-6 weeks minimum
- Be prepared for any response
- Helping your letter writers write the best possible letter: Student resume or brag sheet.

Follow-Up: Handwritten Thank you Card or E-mail





## Essays & Writing Prompts 23-24 Common App: Examples

- 1. Some students have a background, identity, interest, or talent that is so meaningful they believe their application would be incomplete without it. If this sounds like you, then please share your story.
- 2. The lessons we take from obstacles we encounter can be fundamental to later success. Recount a time when you faced a challenge, setback, or failure. How did it affect you, and what did you learn from the experience?
- 3. Reflect on a time when you questioned or challenged a belief or idea. What prompted your thinking?

  What was the outcome?
- 4. Reflect on something that someone has done for you that has made you happy or thankful in a surprising way. How has this gratitude affected or motivated you?
- 5. Discuss an accomplishment, event, or realization that sparked a period of personal growth and a new understanding of yourself or others.
- 6. Describe a topic, idea, or concept you find so engaging that it makes you lose all track of time. Why does it captivate you? What or who do you turn to when you want to learn more?
- 7. Share an essay on any topic of your choice. It can be one you've already written, one that responds to a different prompt, or one of your own design.

## Applying for Financial Aid

- Federal Aid: Federal Student Aid (FAFSA) (studentaid.gov)
  - Generally opens up October 1 for students to complete their senior year
- State Aid: Applications vary by state, NJ is Higher Education Student Assistance Authority (HESAA) (njfams.hesaa.org)
- Sometimes schools may require you to complete the CSS Profile (cssprofile.org)
- Every state has its own funds and process for distributing aid, which often consists of grants and scholarships. Some states only require that you complete a Free Application for Federal Student Aid (FAFSA) form, while other states require families to complete a separate application.
- Some state aid is first come, first served, so complete your FAFSA form early to maximize your eligibility.

## Merit-Based Scholarships

- Generally automatically reviewed for by each school you are applying to
- Important to find out what each school is looking for

Stockton University's Example:

Academic: Official High School Transcript

#### Extracurricular:

Work (part-time or summer jobs) – Volunteerism or Community Engagement – Family responsibilities School/Community clubs/organizations – Arts/Music/Sports – Other experiences that have been meaningful to you

Out-of-State Tuition Scholarship: Cumulative GPA of 3.0 or higher (all GPAs will be converted to a 4.0 scale)



## Athletic Scholarships

- Only about two-percent of high school athletes are awarded athletics scholarships to compete in college.
- Division III: Schools do not offer athletics scholarships
- Division II: Partial Scholarship Model
  - The partial-scholarship model is sometimes referred to as an "equivalency" system. That's because schools in Division II are allowed to award athletics-based financial aid that is "equivalent" to a certain number of full grants in each sport.
- Division I: Division I schools may provide student-athletes with multiyear scholarships. Additionally, Division I schools may pay for student-athletes to finish their bachelor's or master's degrees after they finish playing NCAA sports.

## Grants, Loans and Employment Opportunities

- Grants
  - Potential to receive free institutional, state and/or federal money
  - Some states and/or schools have specific programs
    - NJ: Garden State Guarantee, Educational Opportunity Fund (EOF), Stockton Promise
- Loans
  - Generally students are offered federal loans through the FAFSA
  - Additional Private/Alternative Student Loans are available
  - Federal Parent PLUS Loan is an option
- Employment Opportunities




